## Purpose

---

Terms under which the Photographer licenses specified photographic works to the Licensee for the defined media, territories, term and restrictions.

---

## 1. Definitions

---

**Artwork(s):** The photographic works identified in Schedule 1, including titles and registry IDs.

**COA:** Certificate of Authenticity issued by the Photographer for numbered editions.

**Licensed Use:** The specific media, territories and term set out in Schedule 2.

**Moral Rights:** The Photographer's right of attribution and integrity as recognized under the Berne Convention and applicable national laws.

## 2. Grant of Licence

---

The Photographer grants a **non-exclusive, non-transferable licence** strictly within the Licensed Use. All other rights are reserved.

### Prohibited uses:

- No AI training or dataset creation
- Sublicensing only to approved vendors to execute the Licensed Use

## 3. Restrictions

---

- No alteration beyond proportionate crop or standard colour correction without written approval.
- No logo or trademark use or implied endorsement without consent.

## 4. Credit & Moral Rights

---

**Mandatory credit:** “© Paul Robinson — DasUnit”

Moral rights are asserted internationally.

## 5. Deliverables & Security

---

Files will be supplied at agreed resolutions. The Licensee must secure files against unauthorised copying or scraping.

## 6. Certificates & Registry

---

Editioned prints are controlled via COA and permanent registry. Buyer details must be provided for chain-of-title when relevant.

## 7. Fees & Taxes

---

Fees as per Schedule 3 plus any applicable taxes, duties, or levies. Late payment interest applies per law.

## 8. Warranties & Indemnity

---

The Photographer warrants ownership of the artwork; otherwise provided 'as is' .  
The Licensee indemnifies the Photographer for breach or unlawful use.

## 9. Termination

---

In the event of a **material breach**, the breaching party has **14 days to cure**. Upon termination, the Licensee must cease use and delete files (save legal archives).

## 10. Limitation of Liability

---

Liability is **capped at fees paid**, except for liabilities that cannot be limited by law.

## 11. Governing Law & Jurisdiction

---

This Agreement shall be governed by and construed in accordance with the **laws of England & Wales**. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the **courts of London, UK**.
