Retail price list is attached in Schedule 3. Gallery commission percentage will be agreed in writing. \*Price changes require the **Artists written approval.** 

#### 5. Sales & Title

**Title passes to buyer only when cleared funds are received.** The Gallery will issue invoices showing buyer details to support chain-of-title and will remit proceeds within **30 days of receipt**.

## 6. Promotion & Reproduction

The Gallery may reproduce approved images for **exhibition marketing and press only** (non-commercial). Any other use requires a licence.

### 7. Returns & Damage

Unsold works will be returned in original condition. Loss or damage is the Gallery's responsibility. The Gallery must notify the Artist immediately and provide a condition report.

#### 8. Warranties

The Artist warrants **authorship and authenticity**. Works are editioned and documented per COA and registry.

### 9. Termination

Either party may terminate for **material breach not cured within 7 days**. On termination, the Gallery will return all works and materials without delay.

### 10. General

**Governing law and jurisdiction:** This Agreement is governed by the **laws of the State of New York**. The courts of New York County, New York have exclusive jurisdiction.

This represents the **entire agreement**. No assignment without consent. Notices by email are valid.
